

This is to inform you, our customer, that access to certain areas of your property is required to perform proper treatment of your structure(s) to prevent or eliminate pest problems. We define access to mean gaining accessibility, entry, or going through physical barriers, which are necessary to complete proper application and treatment specifications.

ESSENTIAL PEST Control requests that the customer have a professional licensed contractor make all necessary access arrangements and / or repair of any areas after treatment is completed.

Work required for Essential to gain needed access may consist of the following:

- Cutting into stucco and fascia
- Carpet removal and resetting
- Wood flooring removal and replacement
- Linoleum flooring removal and replacement
- Patching of asphalt or concrete holes
- Core hole drilling through slab, asphalt, or floor
- Drywall removal and / or bath traps
- Hard floor surfaces, but not limited to brick, marble, tile and flagstone
- Coloring on concrete patch will not match existing concrete
- Exterior and interior items must be 3ft away from treatment area, for treatment to take place, if items are not moved Essential will charge \$75.00 per man hour to move items. initials_____
- Damage to furniture or items when moving to gain access to for treatment
- Cutting / removal of bird board
- Cutting in to ceiling or drywall
- Tile roof repair
- Incidental damage to irrigation
- Incidental damage from attic entry
- Incidental damage to plumbing
